WE HAVE ESTABLISHED WAGE RANGES FOR EACH POSITION, AND WE LOOK TO PROVIDE MODEST INCREASES EACH YEAR (IF FUNDS ARE AVAILABLE) TO ADJUST FOR THE INFLATION RATE. WE ALSO BENCHMARK OUR WAGES EVERY FEW YEARS TO MAKE SURE WE ARE IN AN APPROPRIATE RANGE USING THE US BUREAU OF LABOR STATISTICS SALARY STUDY.
